**Terms and Conditions**

**☞ General**

**Accessibility:** Please advise if you have a dog, stairs or a steep driveway at time of booking. As we are a mobile service, we may require the use of warm water and accessible power points. We also require an area that is clear from clutter and very loud noise, if possible.

**Parking:** In the event that parking is unavailable on site, and/ or payment is required for parking, Bronzed and Beautiful Bridal is not liable to cover parking fees whilst attending your event. Please ensure parking is available for one vehicle.

**Change of services:** Due to the timeframes associated with providing beauty services to groups, we are unable to provide changes to the service schedule on the day of the event. If changes are required, we are able to provide changes within 24 hours of the event.

**Additional services:** We are unable to guarantee that we can provide additional services on the day of your event. This will be at the Owners discretion and will depend on the amount of time available for your event.

**☞ Deposit**

All bridal services and packages will attract a deposit of 25% of the total invoice amount payable. Payment of the deposit is due within 21 days of the invoice date. Failure to pay the deposit in full within the 21 day timeframe will result in the date being released and opened to the general public for further bookings.

The deposit amount is non-refundable for cancellations within three months of the event date. 25% of the booking amount will be retained by Bronzed and Beautiful for booking cancellations prior to three months before your event date.

The deposit amount will be deducted from the overall invoice cost.

## **Payment Options**

Full payment for services is due 21 days prior to the date of your event, unless prior arrangements have been made and confirmed by Bronzed and Beautiful.

Bronzed and Beautiful is under no obligation to provide services in the case that full payment has not been made within the specified timeframes, unless prior arrangements have been confirmed and authorised by the Bronzed and Beautiful Account Manager.

We accept direct deposit and Paypal as an acceptable payment method. All payments are to be made in Australian Dollars. Receipts will be sent to your desired billing address, should this be required.

## **Cancellation and Re-arrangement of Dates**

Bronzed and Beautiful will attempt to accommodate you with another date if required, providing a notice period of one month is given.

If less than one months notice is given, Bronzed and Beautiful is under no obligation to accommodate you with a new booking date.

If a new date is not able to be negotiated, the deposit and refund rules will apply. A new deposit will be required for the new date if you have forfeited the previous deposit due to timing issues.

## **Travel Costs**

Bronzed and Beautiful is a mobile service and may charge a travel fee if we are required to travel over 20 kilometres return, from our base. This fee is charged at our discretion.

Travel fees start from a flat rate of \$20.00 return. You will be notified of the final travel cost amount on your invoice.

## **Public Holidays and before 7am starts**

An additional charge of 20% will be charged for all public holiday services, and before 7am starts. This fee is our discretion.

## **Minimum booking amount**

The minimum booking amount required to secure our services is \$250.00. This is at our discretion.

## **Package Inclusions**

Package inclusions are not able to be split between other parties. They are an 'As Is' arrangement, and a deposit must be paid within 21 days of invoice date.

## **Makeup Trials**

Makeup trials are only conducted on Saturdays and Sundays with prior arrangement. We are available for trials after hours with prior arrangement.

## **Non Trial Fee**

A Non-Trial fee of \$25.00 may be charged when a makeup and hair trial has not occurred prior to the wedding day. This is to cover the additional time it takes to set colours on the day and will be charged at our discretion.

## **Gift Voucher Terms and Conditions**

Gift vouchers and unused portions of gift vouchers must be spent within 12 months from the date of purchase, which is the expiry date included on the gift voucher. Gift vouchers that are won in a raffle or fundraiser have an expiry of 3 months from date of issue unless otherwise noted on the voucher.

You must inform Bronzed and Beautiful when you arrange your appointment if you will be redeeming a gift voucher.

Gift vouchers are not redeemable for cash and cannot be returned for a cash refund. Bronzed and Beautiful will not be held responsible for lost or stolen gift vouchers.
